

I have been a fan of Teresa Burrellâ ™s writing since reading The Advocate, her first book in this series, and I have read every one of them leading up to this story. I love the fact that her characters have believable personalities; the situations portrayed are realistic; and the courtroom scenes as they are described (often in great detail) are true to life. Sabre Brown, the protagonist, is a qualified, capable attorney, and some of her cases arise because of her role as a legal advocate for juveniles

within the stateâ ™s Department of Social Services system. Many of her juvenile clients come from abusive homes who find themselves caught up in the trials and tribulations of being in foster care, generally through no fault of their own as is often the case in â œrealâ • life. This most recent book in the series is true to form in that Sabre is defending a young boy, Tray, who sheâ ™s been representing in a dependency case. Tray is accused of murdering his drug-addicted motherâ ™s former live-in boyfriend who was a pedophile. The boy insists he is innocent, yet there is compelling circumstantial evidence to the contrary (with a nun as an eyewitness no less). This makes Sabreâ ™s defense of Tray more complicated even with the help of her co-counsel appointed by the judge. As usual, she calls in her long-time investigator, JP Torn, to aid her in uncovering the facts of the case. Thereâ ™s been intimated sexual tension between JP and Sabre throughout the previous books in this series, although nothing has come of it â " until now. JP is an olâ ™ country boy who spouts JP-isms, adding the element of light-hearted humor in otherwise depressing circumstances. Similar to other books in this series, readers get to go with JP as he follows up on every lead to bolster Sabreâ ™s clientâ ™s case, adding further depth to the story.
