

The problems that I have with Schiff's book about Social Security are as follows:1) It has too much filler material about how Social Security is unworkable. Even without reading this book the average John Q. American citizen already knows that.2) He never covers the jurisdiction of the Social Security Act. The United States Congress has limited jurisdiction in which its law are applicable. Get a copy of the Constitution for the United States of America and read Article 1, Section 8, Clause 17, which clearly states the legislative authority of congress:"To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the Acceptance of Congress, become the Seat of the Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock-Yards, and other needful Buildings;"In other words congress (which is the opposite of progress!) only has jurisdiction in the above defined areas, not in the 50 union states! And it cannot force people in the union states to join it. Here's an interesting United States Supreme Court case that should help you see the light on jurisdiction:"The power of the United States to tax is limited to persons, property, and business within their jurisdiction, as much as that of a state is limited to the same subjects within its jurisdiction." - United States v. Erie Ry. Co., 106 U.S. 327, 333, 1 S.Ct. 223
